## **Re. the bankruptcy of International Automotive Components Group Sweden AB**

Following upon my previous letters in International Automotive Components Group Sweden AB's (the "Company") bankruptcy, I would like to state the following.

As you have previously been informed, the bankruptcy estate will continue to operate the Company's business until it can be transferred to a buyer. The process of finding a buyer to the business is proceeding. A business transfer agreement is likely to be entered into by end of September 2024, with a closing approximately one month later.

The bankruptcy estate continues to guarantee payment for all goods and services provided to the bankruptcy estate from the bankruptcy date and onwards up until the business is transferred to a buyer. The bankruptcy estate has the liquidity and necessary funds to pay for all the deliveries ordered by the bankruptcy estate.

The bankruptcy administration is working hard to pay all the invoices in accordance with communicated payment terms. Nevertheless, we acknowledge that there have been problems with payments, which mainly relates to various discrepancies in the invoices and/or underlying delivery documents. The bankruptcy estate would therefore like to confirm the terms and conditions for deliveries made during the continued operations and at the same time clarify certain matters.

- Payment terms will be 15 days from the day the Company's respectively plants receive the goods (i.e., no advance payment), unless specifically agreed.
- Said payment terms are effective provided that the invoice and/or delivery documents are in accordance with agreed delivery terms as of 27 June 2024.
- Invoices and/or delivery documents that are not in compliance with the above, including, but not limited to, price discrepancies, will result in longer payment terms.

To avoid delay in the payment process, the bankruptcy estate kindly asks you to send your invoice as a pdf by email. Please also send only one invoice per email and send your email only to the one email address (for invoices) relevant for your specific invoice. As previously informed the correct email address for invoices and the correct billing address to the bankruptcy estate is as stated below.
